Slide 1

My name is Andrea Cheerio. I am the global leader 6 star of Amplivo senior coordinator for the core Shell group and Executive director of the Corcel Foundation.

Before I start, we are independent partner of AMPLIVO. We offer a plastic waste removal service, not a financial product. The CSR plastic credit is a digital receipt, which corresponds to a specific quantity of plastic recycled from the environment. No financial licence is required for its sale.

This is a case study of the WWF you can find in their site your plastic diet.org. The men in just approximately 5 grammes of microplastic every week. Let's see this short video.

Slide 5

The Corsair group provides a solution to the pollution from plastic waste using chemical recycling, a process called penalises coarser converts. Plastic waste in advanced bio oil. This oil has a similar characteristic to crude oil and can be used as a raw material for the production of new plastic products.

During this process, we have control emissions because the process takes place respecting the international standards.

High quality oil with low sulphur and CO2 content and there is a huge demand of this oil because of the new European and international laws.

Corsair is a three years ISCC plus certified company, the ISO C Plus certification ensure that the company satisfies environmental sustainability and social requirements recognised worldwide. This is the most important certification you need if you want to sell your oil to big company.

Slide 7

At the moment, the Corsair has two operational facility the Bankgkok one and the Bangkok two in Bangkok, where we have 3 operational plans from 2020 and we have now 5 new plans in installation phase in a total area of 22,000 square metre.

And from now to the end of the year, we will have 20 plants up and running in Bangkok 1, 10 and Bangkok two, another 10.

We have even new facility in Europe already operational in Finland and we there we have one operational plant and another three plants in installation phase, and 10 plants will be up and running from now to the end of 2025 in a total area of 59,000 square metre, with the capacity to have 50 plants there and the capacity of 45,000,000 litre per year.

These are the project operational projects from the Corsair Group and the ones who are under development at the moment with Finland, Sri Lanka, Bangkok 1 under development for 2024 Bangkok 2 Sa Keo Thai North, Thai, South, Holland, Canada, United States and South America.

And the final goal for 2030 of the Corsair Group are 2.5 billion litre every year of pyrolised oil.

Slide 10

We did some important partnership starting from 2024. Huayin and Baston Group leading company in the production of pyrolysis systems supporting the industrial development of Corsair Group International. This collaboration began in 2024 with the acquisition of 23 new pyrolysis plants.

Slide 11

Another important partnership we have with Corsair is with the Count Group, Count energy trading, one of the leading oil brokers in Europe is a buyer of a pyrolysis oil from the Corsair group since 2023 and they sell this oil to the major plastics producers around the world.

And of course, our most important partnership for the Corsair group is Shell, Europe and Shell Asia. So Corsair Group International since 2024 sell its pyrolised oil to Shell Singapore and to shell Chemical Europe.

Slide 13

Corsair Foundation. We support people who are in in difficulties starting with the Bangkok community help. We support people who living in extreme poverty condition by giving them food and funding homes where they can live.

The plastic catch is another initiative in collaboration with the seven Thai Fishing Association. More than 100,000 fishermen, we collect plastic from the ocean, and we deliver to our facility in Bangkok where we transform it to pyrolysis oil.

Trash for cash is other initiative. We donate money in exchange for plastic waste collected in the poorest areas of Thailand.

These are only a part of all the partnership with Corsair has at the moment in Thailand, in Asia and in all Europe.

Slide 15

We were invited, me personally, in the European Parliament in Rome in on April 2023.

Corsair is a guest at the European Parliament to present its industrial solution. The main national media, Taiwan press, have testified to the importance of this great event.

A lot of media and the world talk about us Corsair and CSR plastic credit have attracted the attention of hundreds of media from around the world. Global media reports that the continued growth of the Corsair group, like Yahoo Finance, Law, Vanguardia, Fox, Morning Star, Boston analytic, Euro and others.

So now let's start about the let's to speak about the revolution. The CSR 25 plastic credit. But to understand the greatness of this company and this project, it is essential to take a step back and let's pick just a few seconds regarding the carbon credits market, the carbon credit market. It was born with the Kyoto Protocol in 1997 with the aim of reducing greenhouse gas emission. The CO2, which is the biggest problem in the world.

The new plastic credit market is like a little brother of the carbon credits, which, with with private, private and companies can eliminate their plastic pollution.

This is a big information from Yahoo Finance's \$1.4 trillion, traded inside the carbon credit market just in 2024, and the estimation of this market is \$2.3 trillion within 2028

Offsetting one tonne of CO2 through the carbon credits in 2025, in the beginning cost \$5 for one carbon credit. Today, the seven certification cost \$60.00 because the price of the service carbon credit followed to increase and in the same way will happen to the plastic credit.

Slide 20

Marketing projection by two thousand 2728 the plastic credit market will be the 10% of the carbon credit market, so 2.3 trillion. The 10% is the market in the next three to four years of 230 billions. The Corsair Group International at the moment is the world leader company in the plastic credit market.

By two thousand 2728 with just the 10% of this market, Corsair could reach an annual turnover of \$23 billion per year.

Even the WWF speak about the plastic credit what? Which is the definition of the plastic credit from the WWF.

It is a transferable unit representing a specific amount of plastic collected from the environment and possibly recycled, and this is perfectly what we do. But we not only collect we 100% recycle this plastic.

Slide 22

What are the CSR 25 plastic credits? They are digital receipt, recognised worldwide that certified the removal of plastic waste from the environment. They operate in an open source, highly transparent and reliable database called blockchain. Every CSR 25. and every and every transaction is publicly recorded and can be viewed by anyone.

Slide 23

So what we do is completely transparent.

What you can do for the planet today, thanks to the Corsair Group, international individuals and company can offset their plastic pollution.

How? By purchasing our plastic waste removal service and receiving CSR 25 plastic credits.

Slide 24

Distribution of this CSR 25 plastic credit for each kilogramme of plastic waste recycle from the Corsair group. 10 CSR 25 plastic credits are released on the market, so the most important rule you have to remember is 1 kilogramme are 10 CSR.

This process is being certified by one of the world's leading company. This is the Control Union since 1920, certification and inspection services on the market with over 274 offices and laboratories in over 80 countries worldwide.

And how to become plastic neutral?

First step, Corsair recycles plastic waste worldwide through certified supply chains. Second step for every kilogramme of recycle plastic the Corsair releases into the market 10 CSR. 25 plastic credits. The third step individuals and company purchase our plastic waste removal service to offset their own plastic pollution. Let's make an example. If you want to remove 1000 kilogramme of plastic waste, you need to buy 10,000 CSR 25 plastic credits.

And how to receive the CSR 25 plastic credit? You can go directly on the public market at the market price, for example, in L Bank, one of the top 20 world exchange.

Or you can go through the network and buy these plastic neutral packages that with this plastic waste removal service at a lower price rather than the market, where are they?

But in 20 months, the courser will recycle, will recycle the plastic expected by choosing service and will gradually deliver the CSR 25 plastic credits.

And these are international, some of the international brands partner who already used the CSR plastic credits like Diversity, BDMS, Marriott, Locksley Error, one group, the Totti soccer school, Gioiella and others.
