

US Presentation - Transcript

Hi and thanks for your time. What you're about to hear could completely change your outlook on the future for you, your family, and even the world.

In this presentation, we'll address the pressing issue of plastic waste, introduce Corsair Group International's innovative solutions. Explore the CSR 25 plastic credit revolution and highlight the business opportunities with Amplivo Global.

Plastic waste is projected to reach 460 million metric tonnes in 2025 and new plastic manufacturing is expected to double in the next 20 years.

With plastic accounting for 12% of all waste and less than 9% of it being recycled, the need for effective solutions is urgent. The estimated time for common plastics to biodegrade is staggering.

When you consider that a plastic bottle takes 450 years to biodegrade, you can see how the scourge of plastic waste affects every country, every ocean and every neighbourhood. No wonder this plastic waste problem seems like a hopeless ticking time bomb.

But what if there was a major solution for plastic pollution?

What if there was a way to turn that plastic into a valuable resource? And there is.

The Corsair group is here to tackle this.

Plunge. For years, the world has struggled with plastic waste, yet solutions have remained inadequate, says Jussi Tolerante, CEO of Corsair. We knew we had to think differently. Instead of seeing plastic as a problem, we decided to see it as an opportunity.

Corsair's innovative process turns plastic waste into a bio oil called pyrolysis oil, a crucial ingredient for producing new plastics. This isn't just another effort to recycle plastic bottles or repurpose use containers. It's a fundamental shift in how plastic waste is processed, turning it from an environmental burden into a valuable resource.

Corsair's facilities are designed to process vast amounts of discarded plastic, refining it into pyrolysis oil that can then be used to create new high quality plastic products. It's a true circular economy model that when scaled globally like is happening now, could change how the world deals with plastic pollution.

Corsair's efforts have not gone unnoticed. Over the last five years, an impressive list of partner companies have joined Corsairs cause to declare themselves plastic neutral by offsetting their plastic footprints.

They do this using something called a CSR plastic credit. More about that in a minute. These are large billion dollar companies, many of which you're familiar with. Companies like Ford, Nissan, Lexus, Hyatt and Marriott.

And why would they want to do this? Well, 2 main reasons. One, they want to be good corporate citizens and they want to be able to tell the world I am plastic neutral. But the second reason may be more compelling.

Right now, governments around the world are creating new regulations that will essentially force plastic manufacturing and plastic using companies to offset their plastic footprints or

face heavy fines if they don't. For example, new EU regulations require plastic companies to use 30% recycled plastic for their new products.

And that required percentage amount is expected to increase every year. Many other countries like Canada, Australia and even some U.S. states are starting to implement plastic waste regulations right now.

Legal actions against companies for false claims about recycled plastic highlights the importance of transparency. For example, in April of 2025, Clorox Australia was fined over \$5,000,000 for inaccurate recycling claims on their packaging. Not that they didn't use recycled plastic, just claiming that they got it from the ocean, when they really got the plastic from 50 miles inland. So how does a company comply with the regulations and prove their compliance? There are really only two ways.

Either they buy and use bio oil or they offset their plastic use with a plastic credit like our CSR 25 credit with CSR 25 plastic credits. We're making that accountability measurable and transparent for every litre of pyrolysis oil Corsair produces from plastic waste.

10 CSR 25 plastic credits are issued to the person or company that placed the order.

The CSR 25 credits are created or minted on the Ethereum blockchain using something called a smart contract. This smart contract embeds into the CSR 25 credit specific information like when and where the bio oil was created and where the plastic came from the CSR 25.

Really acts like a digital receipt for the bio oil production and is called a proof of work or POW token. It also has a monetary value because it can be bought and sold on an open exchange.

So now that we understand the scale of the global plastic problem, what Corsair is doing about it and how the CSR 25 credits work? Let's talk about Amplivo and the tremendous opportunity it presents for you right now. Amplivo is the direct sales partner to Corsair, and Amplivo associates are positioned to join the cause ahead of the giant wave that's about to hit.

In 2024, Corsair signed agreements with Shell to supply all the oil it can produce from its facilities in Thailand and Finland. Corsair also signed on to the one Bali project, a massive endeavour to clean up and recycle ocean waste in Indonesia in collaboration with Saudi Aramco. Exxon Mobil has also entered the Bio oil game in a very big way, and what do they all need more bio oil.

In response, Corsair is rapidly expanding with new facilities being developed in Asia, Europe and North America. The goal to process over a billion kilogrammes of plastic waste annually, preventing it from ever reaching landfills or polluting natural ecosystems. It is estimated that 1.64 Trillion dollars of investment will be required by 2040 to combat plastic pollution and comply with looming regulations. Amplivo is at the forefront, providing sustainable solutions and opportunities for investment in a cleaner future.

At Amplivo, we like to say that we can do well by doing good.
